**RECENT NOTABLE CASES:**

*Charles Wilson vs. Jefferson County Commissioners, et al.* – In June 2008, Charles Wilson, a Jefferson County resident, filed a class action lawsuit to recover, among other things, exorbitant brokerage fees that were paid to brokers and investment banks around the country by Jefferson County for sewer bond deals. The firm has alleged a total loss of over \$100,000,000, and represents the class.

*Fannie Wayne vs. Monsanto Corporation, et al.* – Fannie Wayne, along with thousands of other clients, filed a series of lawsuits over the alleged pollution of PCBs in the Anniston, Alabama area. The firm represents over 500 clients in that litigation which is being handled in Jefferson County, Alabama.

*Daniel Kahn vs. Fortis Insurance Company, et al.* – Daniel Kahn filed a class action lawsuit in Fulton County, Georgia related to artificial health insurance premium increases that allegedly violate Georgia statutes and insurance regulations. This state-wide litigation was certified by the Court and the firm serves as co-lead counsel.
